**ORDER**

[1] Pursuant to paragraph 62, item 2 of the Order of the Environmental Review Tribunal (“Tribunal”) issued February 28, 2017, and pursuant to the agreement of the parties regarding dates for completion of the Work Items in Part 3a and Items No. 13 to 16 of Part 3d of Director’s Order No. 3506-A8QGC3, the Tribunal orders that the Director is directed to amend Director’s Order No. 3506-A8QGC3 as follows:
